

WHAT AND WHO ARE REALLY BEHIND THE REDEVELOPMENT PETITIONS CURRENTLY BEING CIRCULATED IN ST. PETE BEACH?

THE PETITIONS ARE BEING CIRCULATED BY A POLITICAL ACTION COMMITTEE (PAC) ANONYMOUSLY NAMED "SAVE OUR LITTLE VILLAGE (*SOLV*)"

THIS SOUNDS LIKE ITS MEMBERS WOULD BE A GROUP OF EVERYONE'S FAVORITE GRANNIES HAVING AFTERNOON TEA ON A SUNNY SUMMER DAY

YOU MAY THINK THAT SAVING THE LITTLE VILLAGE MEANS KEEPING THE SMALL TOWN ATMOSPHERE OF ST. PETE BEACH

FAR FROM IT

CRG BELIEVES THERE IS AN EFFORT TO CAMOUFLAGE THE INTERESTS BEHIND "*SOLV*" – THE REAL INTENT BEHIND GETTING SIGNATURES ON THE PETITIONS IS TO INTRODUCE A NEW REDEVELOPMENT PLAN BY STEALTH

THE PETITIONS EACH CONTAIN LANGUAGE THAT, WHEN TAKEN TOGETHER, WILL ALLOW DEVELOPERS TO BUILD HUGE BUILDINGS AND URBANIZE ST. PETE BEACH

THIS IS THE FIRST OF A NUMBER OF ADS THAT WILL POINT OUT HOW THE "*SOLV*" PETITIONS LIKELY WILL HAVE RESULTS FAR DIFFERENT FROM THOSE IMPLIED IN THE PETITION SUMMARIES

GO TO CITY HALL AND ASK TO SEE A COPY OF THE "BALLOT SUMMARY" FOR "PETITION 3" WHICH "*SOLV*" WANTS YOU TO SIGN

YOU WILL SEE ON THE FIRST PAGE THAT IF *SOLV'S* "PETITION 3" BECOMES LAW:

- (1) 12-STORY BUILDINGS WILL BE PERMITTED ON THE BEACH, AND
- (2) DENSITY WILL BE INCREASED FROM 30 TO 80 UNITS PER ACRE

ALSO BE SURE TO READ THE FINE PRINT IN THE 11 PAGES IN "PETITION 3"

ON PAGE 1 UNDER "PERMITTED USES AND STRUCTURES" YOU WILL FIND:

- (1) "**CONDOMINIUM HOTELS**" AND
- (2) "**MULTIFAMILY DWELLINGS**"

AND ON PAGE 2 IT SAYS: "RESIDENTIAL AND TRANSIENT ACCOMMODATION UNITS ARE PERMITTED TO BE MIXED WITHIN PROJECTS AND STRUCTURES"

WE BET THEY DIDN'T POINT THIS OUT TO THE PEOPLE THEY ARE URGING TO SIGN THE PETITIONS

THAT SURE SOUNDS LIKE MORE TALL BUILDINGS AND MORE CONDOS TO US!
