CRG BELIEVES THE "SAVE OUR LITTLE VILLAGE" (SOLV) PAC'S FOUR PETITIONS – SUPPORTED BY THE BIG DEVELOPERS – WILL OPEN THE URBANIZATION FLOOD GATES IN ST. PETE BEACH:

ABOUT 5,000 ADDITIONAL LIVING UNITS (CONDOS) WILL BE ALLOWED
THE DEVIL IS IN THE 'SOLV' PETITIONS' DETAILS:

- **'SOLV' PETITIONS 1 & 3 ('THE URBANIZERS')**: ALLOW DENSITY FOR CONDO-HOTELS TO BE INCREASED FROM 30 UNITS PER ACRE TO 80 OR MORE UNITS PER ACRE (Check at the Clerk's Office at City Hall. Read the two "Density" paragraphs on Page 36 and the density charts on Pages 57, 58 and 59 of Petition 1; and Paragraph "(g)" Page 3 of Petition 3)
- **'SOLV' PETITIONS 2 ('THE SKY IS THE LIMIT')**: PERMITS BUILDINGS OF *UNLIMITED HEIGHT – 20 OR MORE STORIES* (See Policy 1.2.2 on the 6th & 5th pages from the end of Petition 2. Policy 1.2.2 permits height increases far beyond the 12 story limit claimed by 'SOLV' in the "Ballot Summary" on the 1st page of Petition 3. Unlimited height increases can be given for unspecified increases in open space.)
- **'SOLV' PETITION 4 ('THE DOLPHINIZER')**: PERMITS STILL MORE TALL CONDOS THROUGHOUT ST. PETE BEACH INCLUDING AREAS WHERE *NO* CONDOS CURRENTLY ARE PERMITTED, SUCH AS ON COREY AVE. (See Pages 1, 5, 6 & 7 of Attachment A to Petition 4 and Policy 1.2.2 form Petition 2 above.)
